

TERMS OF RELEASE OF LIABILITY & HOLD HARMLESS

I will participate in the BrainStorm Summit . I am 18 years or older and provide my consent for me and any child of mine under 18 accompanying me.

I understand that some subjects discussed at the BrainStorm Summit lectures, round tables, panels or breakout sessions surrounding human health, pediatric cancer, brain cancer, donation of tissue, feelings of emotional distress or grief may trigger emotions or memories of situations I have experienced as a person who has or has had cancer, a parent of such person, a medical provider of such person, an advocate or other relationship to such memories.

While the BrainStorm Summit does not require physically strenuous activity, I have familiarized myself with the physical demands involved in navigating the venue by stairs or elevator to participate and have considered the demand of participation. I am in good physical condition and can meet those physical demands. I understand the event will follow safety protocols for COVID 19 prescribed by law for the Washington, DC.

I understand that the food for the day has been prepared by the venue staff. The organizations and individuals planning this event have no control over the preparation of food or selection of ingredients. Accordingly, I assume all risk in maintaining my health despite any dietary requirements or allergies to food or drink I may encounter during the BrainStorm Summit.

I understand I can leave the venue, or retreat to a quiet area inside or outside the venue at any time.

I understand there will not be a dedicated medical or emotional support team provided on site.

However, I can alert event staff should I require emergency medical attention to call 911.

Having prepared myself for the BrainStorm Summit, I also agree to release, hold harmless and indemnify AWOCCF, Inc., Tough2gether Against DIPG, the event sponsors listed in the program, the team planning the event, the JW Marriott Hotel and/or the National Press Club which is the venue as the case may be and their officers, trustees, directors, employees, and agents, from and against any and all claims, demands, and judgments arising from injuries or damages in connection with my participation in the project.

I grant permission to be photographed or video recorded and/or to use my name in connection with such, during CureFest and the BrainStorm Summit by news media, event media, for promotion of

event, AWOCFF, Inc., Tough2gether Against DIPG, or any of the event sponsors or their agents, to allow any to reproduce any portion of the photo images for the purpose of organization, event or childhood cancer awareness or advocacy promotion in print, video, or internet or computer based media without any compensation or recognition given to me.
